## **COVID Update**

- On Wednesday, April 7, there was one active case in the district.
- The next day, 8 more cases were reported; 6 were traced to one birthday party.

- By Wednesday, April 14, there were 27 active cases in the Division requiring the quarantine of 980 students and 100 staff. This is posing significant challenges to operations due to the depletion of the substitute pool.
- The Division may need to transition students in specific schools or grades to a temporary teacher-led online learning model.
- Lowering community spread is critical to maintaining in-school learning.

## 2021-2022 Budget Planning Update

- On March 31, EIPS received its funding letter and the funding manual for the 2021-22 budget.
  - o Initial review indicates that total funding to the division is the same as last year, though there are some changes to specific grants within the whole envelope.
  - o No change to per student basic grant or to transportation funding.
  - o Changes to Learning Supports Funding Grants (PUF for Kindergarten restored to fall 2019 amounts, not 2018-19 amounts; per student LSF reduced.)
- Budget discussions: ½ day budget session on March 18 and full day March 25 and most of April 8. The discussions will continue on April 15 and 19.
- April 22 Board will be approving fees (both division and school) and school allocations so be sure to include school budgets on your May school council meeting agendas.
- Considerations:
  - o It is anticipated that EIPS will realize a significant surplus from operations this year.
    - Increased revenue due to Alberta Education's announcement to "hold harmless" on any funding claw backs that would result from lower than projected enrolment. This is good news but the fall budget had included \$1.9 million in deferred revenue that will now be realized.
    - Lower than budgeted costs such as janitorial, PD (were held virtually or cancelled) and, most significantly, COVID-related illness costs—an unknown that was very difficult to budget for.
  - o As per Bill 5, school boards' operating reserves will be capped at 3.1% of operating budgets including reserves in school generated funds. This means that the board will have to spend down reserves over the next two years. The board is working on a reserve spending plan to ensure strategic use of these funds. Sustainability will be key, i.e., a focus on one-time items as opposed to ongoing costs.
  - o Covid recovery will definitely an have impact on next year's costs, e.g., continued health protocols and addressing learning gaps.

#### **2021-2022 School Year**

- Per cues from the Minister of Education, EIPS is planning on near normal operations w/ health protocols. This direction is based on anticipated vaccine levels and confirmation of the importance of in-school learning.
- Focus will be on learning loss mitigation, safety and providing a school experience as close to normal as possible.
- Operational decisions such as protocols, cohorting, entry dates, etc., have not been made. The division will keep parents informed.
- Next Step will be moving its Sherwood Park outreach campus into Salisbury Composite High School.

### Special Board Meeting - April 8

The board approved an amendment to its modular classroom request to Alberta Education/Infrastructure to cover the costs of moving 6 modulars (original # was 4): 4 from Campbelltown and 2 from Pine Street to address enrolment pressures at SouthPointe and Ardrossan Junior/Senior.

The board approved the use of To Be Allocated funds to hire three temporary family liaison workers to connect with out-of-school students/families residing outside Strathcona County with whom we've had limited contact. The goal is to make contact and determine if supports are needed to ensure a successful 2021-22 school year.

## **Technology Fee**

The board has decided to postpone any further discussions around a technology fee until after administration provides its updated division technology plan next year.

#### K-6 Draft Curriculum

- In advance of seeing the draft curriculum, EIPS Superintendent Liguori advised that the division will not be participating in the pilot.
  - o This would have been year 3 of disruption for staff and students.
  - o Focus is on addressing gaps and have as normal of a year as possible for both staff and students. Next year is especially important for grade 3 students as all the research shows that meeting literacy targets by grade 3 is critical to future success in education, and subsequently, in life.
  - o Would have required significant investment of resources when the government is saying it will be making ongoing adjustments.
  - o Time constraints.
- The Board and Division are reviewing the draft K-6 curriculum and collecting input from groups of teachers to provide to the province. Feedback from parents and community members will also inform our response. The intention is to provide an over-arching summary to the public.
